### Massachusetts Marketing Partnership

On August 5, Governor Patrick signed an economic development bill into law to promote job growth, long-term economic recovery, and transparency of services available to the private and public sectors. One section of the bill created of **Massachusetts Marketing Partnership, on which MassEcon was appointed a board seat.** Other parts of the bill established the Massachusetts Growth Capital Corporation; provided for MassDevelopment to absorb HEFA's role; and granted regional economic development groups a formal role in the statewide economic development. 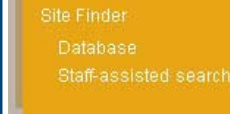

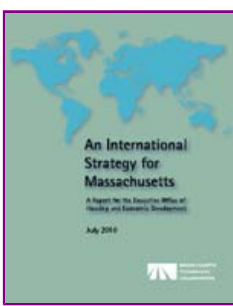

rough. If our members know of these types of facilities, it would be great to learn more about them.

**#2383:** MassEcon was contacted by MOBD for an international manufacturer of transit cars for a facility to lease or buy in Massachusetts. The search for this 116,000-192,000 SF building was statewide and the requirements included: 30-50 FT clear in manufacturing area, 2-3 loading docks, heavy power (500 kilowatts +), on freight rail, and good access to a port either via rail or roadway. The company also needed adjacent land to the building for a test track. *Notes: After the Bulletin was sent out, MassEcon took the company's consultants on a tour of 16 properties in Massachusetts – from the Berkshires to Boston - and took advantage of regional economic development groups to give an overview of each of the regions. This was extremely helpful to the client. Three sites have been shortlisted, two of which are in our Market Ready inventory.*

**#2388:** MassEcon was invited to a meeting with an international biotech manufacturer seeking to lease 25,000 SF in Massachusetts. The company would prefer to be in the Greater Boston area but would consider other areas if requirements are met. The requirements are: 6,000 SF of office space, 15,000 SF of wet lab space, and approx. 4,000 SF of clean room space. They would prefer to be near public transportation as well. *Notes: The company is looking to come to Massachusetts as a result of incentives being cut in Ontario. It seems that when the incentives dry up and companies have a choice of location, Massachusetts can enter back into the mix. The promise of "cash" from other places leaves a bad taste in their mouths when that promised incentive does not come through. Massachusetts's setup and incentives programs – because they are not based on a blank checkbook and promises – seem a good course of action.*

**#2391:** A national site location consultant contacted MassEcon to help with a manufacturer of next generation aerospace components. The company needs a minimum of 20 acres to build a 218,000 square foot facility. There are some specific utility requirements including: water 175,100 g/month, wastewater 160,040 g/month, electric up to 3700 kW demand, and natural gas to the site. The company would also prefer good highway access. *Notes: MassEcon's charge was not only site finding but to provide research on employment, demographics, and other factors relevant to the location decision. This furthers our belief that MassEcon's interaction and strong relationships with the consultants is integral to business development for the state.*
